Why is NCIDQ Certification Important?

- Industry Standard
- Differentiator



- Recognized by nearly all regulated jurisdictions in North America
- Increased Salary Potential
 - NCIDQ certification makes a difference. Median salary is \$16k higher compared to those not currently holding any type of certifications and credentials. Source: ASID 2019 Interior Design Salaries & Benefits: General Report
 - Those with an NCIDQ certification reported a median salary \$10,000 greater than those without (\$70,000 versus \$60,000).

The NCIDQ Exam consists of 3 separate sections:


| Exam Name | Format | Number of Questions | Duration |
|---------------------|---|---------------------|----------|
| Fundamentals (IDFX) | Multiple Choice | 125* | 3 hours |
| Professional (IDPX) | Multiple Choice | 175* | 4 hours |
| Practicum (PRAC) | Hot Spot, Drag and Place, Fill in the Blank | 120 | 4 hours |

*The IDFX and IDPX Exams each contain 25 ungraded pre-test questions.












Practicum Exam






Eligibility Paths and Work Experience

- To be eligible for the exam, individuals must complete a combination of both education and work experience. There is also an alternative pathway for those who do not meet one of the traditional paths.
- All interior design work experience hours must be signed off on by either a direct supervisor and/or sponsor

Meeting CIDQ's education and work experience requirements does not guarantee that a candidate will meet their jurisdiction's requirements to be a licensed/registered/certified interior designer. Individuals are reminded to check with their jurisdiction regarding those specific requirements.





Application Requirements

IDFX ONLY

- Mail in official transcript(s).
- Pay application fee and submit.

PLUS (after approval of IDFX ONLY and completion of work experience)

- Mail in official transcript(s).
- Upload completed work verification form(s).
- Pay application fee and submit.

OR

All Three (3) Sections of Exam (IDFX, IDPX, PRAC)

- Mail in official transcript(s).
- Upload completed work verification form(s).
- Pay application fee and submit.



COVID-19 Response

- Spring (April) 2020 exams were postponed to fall (October) 2020
- Applications are still being accepted as normal deadline to apply for fall is July 31
 - Recommend sending transcripts via USPS with tracking (staff going into office once a week to process mail)
 - No staff are at the office to sign for or accept FedEx and UPS deliveries
- New blueprints will go into effect with spring (April) 2021 exam administration
- Fall (October) 2020 exam administration expanded approved candidates will be eligible to test October 1 – November 24
